**Local Ambulance Corps Carries on Until V-J Day**

The Manchester Ambulance Transportation Corps will remain intact until the surrender of Japan, Major Alice M. Madden stated today in the wake of the abolishment of all the various branches of the Civilian Defense in Manchester.  
"Our unit was not notified about the abolishment of Civilian Defense," said Major Madden today. "I knew nothing of this until I saw it in the paper. This unit will remain together until Tokyo is dropped and then I'll be the first to drop it."  
Major Madden has issued an appeal to the girls of the unit which during the early days of the war did so much to further various municipal and CD interests. Originally formed by Jack Dwyer, former sports editor of the Herald, Major Madden is a member of the unit.  
"I'm glad to see the unit is being kept together," declared Major Madden. "We have no objective at present but should an emergency occur in town our girls would be needed."  
Headquarters of the unit is in the Sports Center on Wall street. Applications will be received by Major Madden for membership in the unit.

yesterday reiterated that country's insistence on unconditional surrender by the Japanese military and naval forces. But Mr. Truman then asked what unconditional surrender means for the Japanese people and supplied this answer:  
"It means the end of the war. It means the termination of the influence of the military leaders who have brought Japan to the present brink of disaster."  
"It means provision for the return of soldiers and sailors to their families, their farms, their jobs."  
"It means no prolonging of the present agony and suffering of the Japanese in the vain hope of victory."  
"Unconditional surrender does not mean the extermination or enslavement of the Japanese people," Senator Hart (R., Conn.) called the "irrevocable" statement an important addition to the unconditional surrender formula.  
"It means that we will not insist upon complete victory," but as stating "irrevocable" conditions of unconditional surrender, namely that the farms and jobs of the Japanese will not be destroyed and that their soldiers and sailors will be allowed to return to their homes."  
"I am delighted that the president issued that statement. I have nothing to add to it and I would not change it."

London to consult Stanislaw Mikolajczyk, former premier of the Polish government in exile, who is acceptable to the Russians as a member of a reconstituted wartime regime. Molotov's route back to Russia was not disclosed.  
The fundamental obstacle to establishment of a new Polish government was understood to be a difference between Russian and Anglo-American interpretation of the Roosevelt-Churchill-Stalin agreement reached at Yalta for broadening the Warsaw provisional government.  
The Russians insisted the three-power commission should meet first with the Soviet-recognized Polish government, and build a new regime around that group, while the Americans and British held that they should start anew, meeting with representatives of all Polish factions.  
After the Yalta conference, it was learned, the United States and Britain drew up three lists of possible Polish governments, lettered A, B and C, in order of preference. Three of the underground leaders arrested by the Russians were understood to have been named on the lists, but they came out of hiding at their own initiative—not at American and British suggestion.  
Molotov's announcement to Secretary of State Stettinius and Foreign Secretary Eden that they had been arrested capped the break in Polish negotiations factually, but it was learned that the arrests would not be permitted to interfere with continuation of the talks in Moscow.  
If negotiations were broken off indefinitely, the present deadlock might drag on for a year or more, permitting the Soviet-sponsored regime to strengthen itself.  
Reports from inside Poland reaching British-Americans here said the Russians were "unbending," but the government set up at Lublin, so far, is "not popular."  
Molotov's last public appearance in San Francisco was at a cocktail party he gave in the Saint Francis hotel last night for the Ukrainian and White Russian delegations. It

**Called to Discuss Coal Contract**  
 Washington, May 9.—As-thrastic operators and miners were summoned to meet with the Interior Secretary today to discuss a coal contract which has been held up for some time.  
 What did it cost for this greatest military feat of all time? How many lives paid for the great oil campaign? How many lives paid for the great coal campaign?  
 One index comes from the estimated total of American casualties in the European theater. They are estimated at a total of some 700,000, of which about 145,000 represent our dead. This is a price large enough to spread sorrow across America.  
 Battles had to be fought and won, and it is their comparative cost which counts for present purposes.  
 These 145,000 dead represent the price for the major, inescapable operations without which the war in Europe could never have been brought to an end. Best cost estimate is that that total war cost both sides nine or ten millions in battle dead. Against that total cost our 145,000 dead for the most part are a drop in the bucket. It is almost unbelievably light.  
 Future military historians, then, are likely to find that never in history has so much been gained at relatively low cost in human life.  
 "There was never any secret about the strategy which made this possible.
