Greek Premier Unhurt In Bombing Attempt

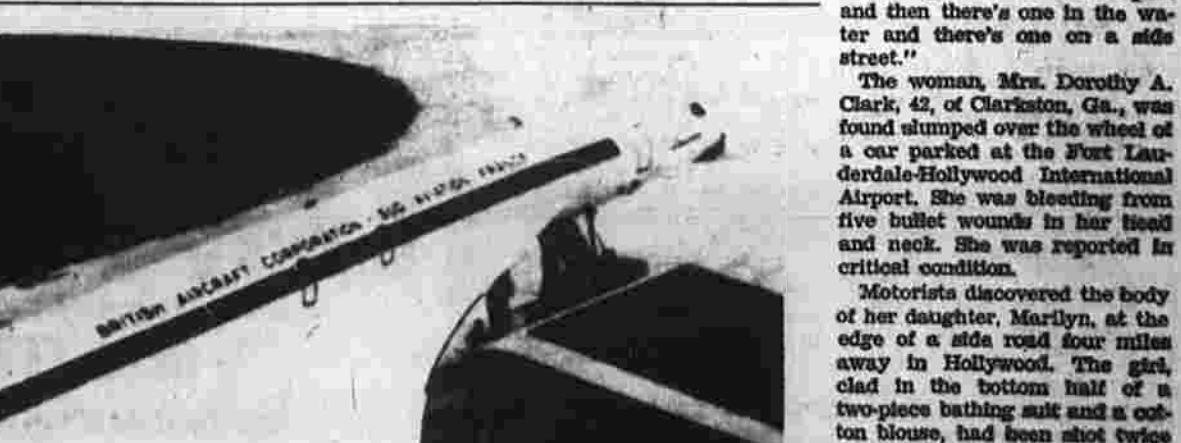
ATHENS, Greece (AP) — An attempt to assassinate strongman Premier George Papadopoulos was made today on a road outside Athens and later at least two bombs were exploded in Athens, a government spokesman said.

### Guards Cleared After Probe of Brutality Charge

HARTFORD (AP) — Four guards at the State Farm for Women in Mansfield have been cleared of brutality charges lodged by the mother of an inmate.

The investigation by state police was ordered by Commissioner Ellis C. MacDougall of the Department of Correction following the complaint, which was made Saturday.

The incident occurred last Wednesday when inmate Jane Cooper, 19, of Bridgeport, refused to go to the institution's infirmary for treatment of a sarcoma. A spokesman at the infirmary said transfer to the medical unit is mandatory when an inmate requires medical attention.

The spokesman said Miss Cooper dialed one of the nurses, refused to go to infirmary and resisted efforts by female guards to take her there. Four male guards joined to help.

Miss Cooper finally was taken to the prison's security unit and she agreed to go to the infirmary, where her sarcoma was treated.

Miss Cooper's mother, Jennie Hunted, made the complaint. State police talked with all parties involved, including a representative of the Bridgeport branch of the National Association for the Advancement of Colored People, and then cleared the four guards.

### Apollo Craft Ground Tests Begin Today

CAPT. KENNEDY, Fla. (AP) — Ground testing begins today on the Apollo spaceship that will fly aboard the first manned mission 500 miles higher in January.

The cone-shaped moonship arrived at Cape Kennedy Monday after a cross-country airplane trip from the plant at its prime contractor, North American Rockwell Corp., at Downey, Calif.

Scheduled to ride the space shuttle in January are Air Force Lt. Col. James A. McDivitt and David F. Scott and Russell L. Schweickart, a civilian astronaut. Their flight, named Apollo 8, will be the first manned mission aboard a 28-foot-tall Saturn 5 rocket, the type of booster which is to hurtle three astronauts to the moon late next year.

In late October or early November of this year, three other astronauts—Navy Capt. Walter M. Schirra Jr., Air Force Capt. Donn F. Eisele and Walter Cunningham, a civilian—are scheduled to make America's first three-man space flight. They will be launched by a Saturn rocket, however, forecasting the larger Saturn 5 man-to-moon booster.

The Special Point Candidates

Senator George McGovern, the South Dakota Democrat, proclaims his candidacy for his party's nomination for President because, he says, he wants to work "to tame the savagery of man and to subvert the life of the world." But that lovely, general phrase is the cover for the fact that Senator McGovern wants to make particular points in the presidential campaign.

The Nixon Nomination

On that improbable sunset strip that is Miami Beach, the Republican Party held its annual convention to nominate Richard M. Nixon for his party's nomination for President. Nixon — for his fealty, his consistency, and his dedication with the nomination for the presidency of the United States.

Senator McGovern's candidacy

Senator McGovern's candidacy thus becomes another of the special point candidates which abound in this presidential year.

It is, in a sense, a duplication of Senator McCarthy's candidacy, offered to provide a substitute for those who share the McCarthy view on Vietnam without developing enthusiasm for McCarthy the man as a candidate.

Both the McCarthy and the McGovern special point candidates run counter to the special point candidacy of former Governor Wallace of Alabama. He runs the presidential campaign in the name of giving expression to his theories on the issues of race relations, and the point he makes is sharp even though the substance of his campaigning is "I believe in civil rights, even for white people."

One would think that the candidacy of Wallace would satisfy little Lester Maddox, the erstwhile restaurant owner who is now governor of the great state of Georgia. But he has a special point of his own he would like to see made. To his point of view, the great fear of Americans, and especially of the South, is not communism, as Maddox and we're not satisfied that even Nixon is going to be conservative enough for his view.

There may be more than minute special point candidates before the people of this country find their way to the polls in November.

When they get to those polls, however, chances are that they will find their choice generally in the name of a candidate who have made a point of not making any single special point too prominent in their own campaigning.

And the truth about the voters, too, will be that they will actually feel more comfortable voting for some candidate who has been careful not to make any very special points at all than they would feel voting for some candidate who had shown himself motivated by and concentrating upon one single argument and issue.

This wariness of the voter of the man who has given himself to a single issue can exist even if the issue the candidate has specialized in is the issue closest to the voter's own heart.

In the acid test, even the voters may shun the candidate who is too honest, too forthright, in favor of the candidate who takes pains to be something of all things to all men. The sad predicament — perhaps, in the end, a wise practice — is that we sometimes tend to choose the man who can avoid an issue over the man who insists on meeting it head-on.

The actual truth about us as voters is probably that we like to have a healthy debate on all the issues that are before us. We want to believe we are voting for an individual who is honest and courageous and who can be depended upon to give the right answer to specific issues. But we have a tendency to be afraid of candidates who look and speak and act as if they might actually believe in any particular theory or principle so strongly they would even trap themselves and us in any desperate commitment to it.

It could be, one sees, that the candidates who make their way to the top by sticking to gross generalities and adding cheap specifics to the top because that is where we want them to be.

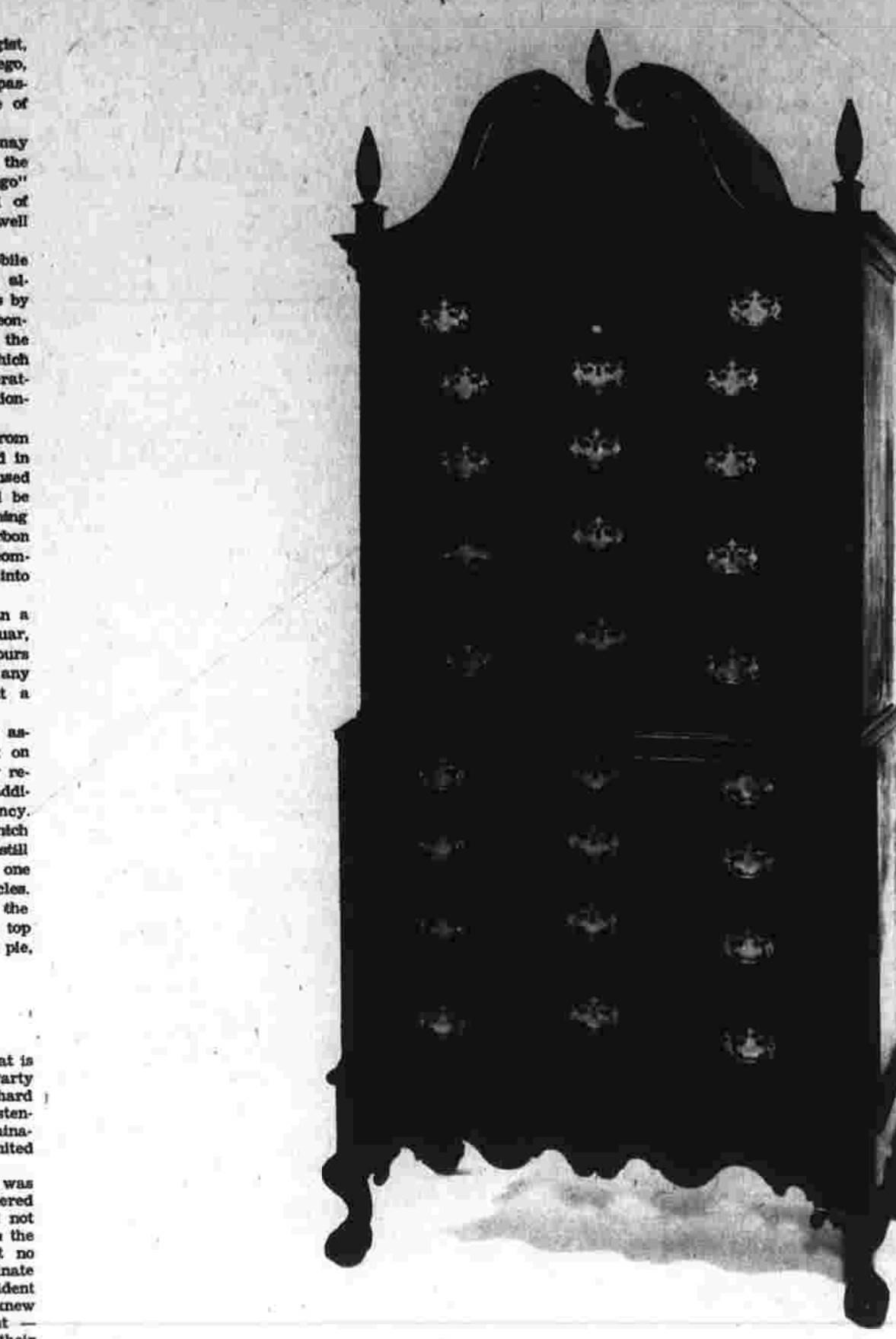

You can forget all about the pre-convention calculations of certain Connecticut Republicans that Governor Rockefeller would have been a greater blessing to various Republican candidates in Connecticut than Governor Nixon will.

The Connecticut Republicans who once calculated that they have already stopped letting it get them down.

To the contrary, they are still on the way to a state of euphoria about the 1968 campaign, on every level.

Their sense of well being is one part relief, one part satisfaction, and one part the kind of blissful ignorance that is the lot of many voters who are not hard-working politicians.

From the national point of view, they know that Nixon is safe and reliable as a candidate. They know that Rockefeller is not going to consider him some kind of conservative hawk, which would mean that they would not have to worry about Rockefeller's possible reaction to the party's nomination of Nixon.

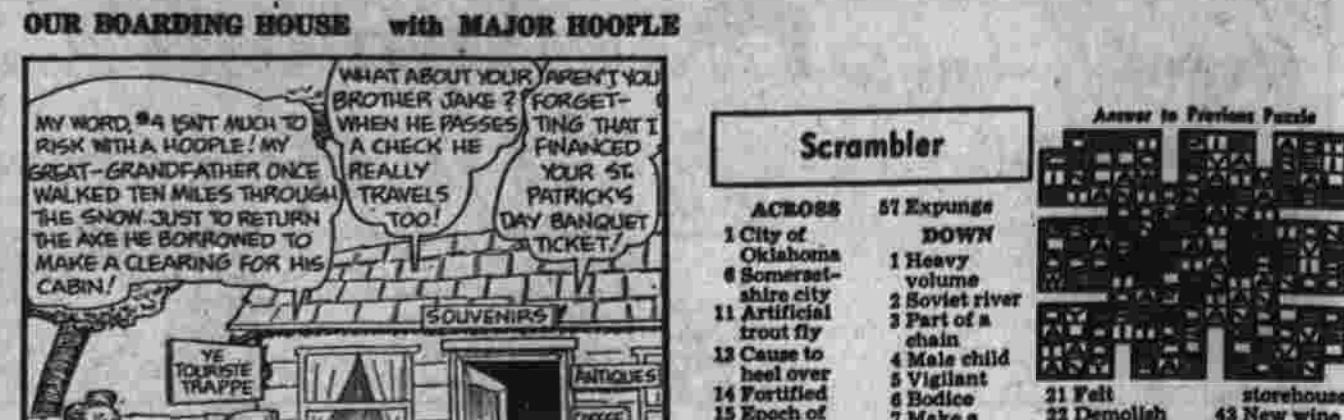

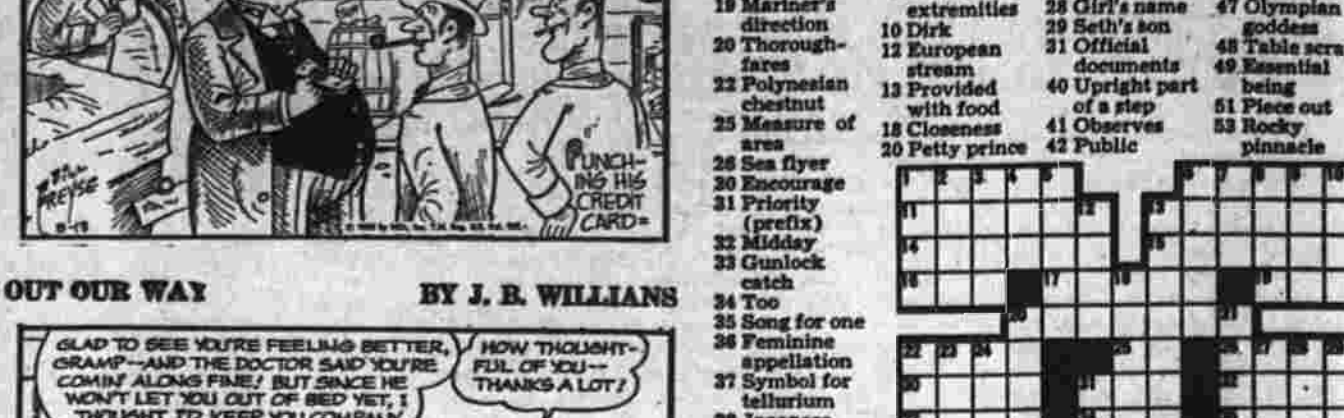

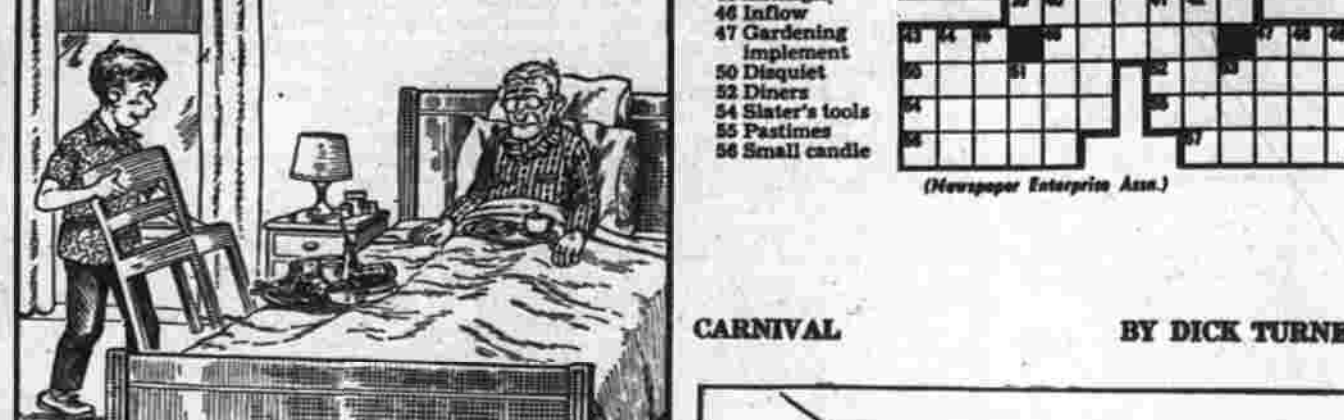

Nigeria Said Starting Push Against Aba

LAGOS, Nigeria (AP) — Two columns of Nigerian commandos were reported pushing north today toward Aba, a highland stronghold of Aba in what would be the start of an all-out offensive to crush the Biafran secession of eastern Nigeria's Biafran provinces.

Informal sources said at least two brigades of Nigeria's 2nd Marine Commando Division were advancing from Port Harcourt sector toward Aba, the largest of the three towns still under secessionist control.

The military high command in Lagos refused to divulge details of the offensive, but a high ranking officer said troops commanded by Col. Benjamin Adekunle were reported trying to cross the Ino River, 15 miles south of Aba. Another source was believed pushing north along the river to the Ino railway station, about 25 miles from Aba.

Aba, which had a pre-war population of 121,000, has been the command headquarters for the Biafran regime of Lt. Col. C. Oghuenigbo since federal forces captured the city in late April. Biafran forces, led by Lt. Col. Umu Abayi, on the southern bank of the Ino River, has been under heavy mortar attack for the past three days. The broadcast said 25,000 civilians were fleeing and that Biafran authorities were undertaking a massive civilian evacuation from the town.

Fighting also was reported around Idah, a refugee camp of about 25 miles northeast of Aba. Commanders of the three Nigerian divisions surrounding the core of Biafran-held territory met in Lagos today, presumably to plan a final offensive.

"We will be clearing our minds this morning," said one participant. The new fighting was reported as Biafran forces in the Ethiopian capital Addis Ababa. Emperor Haile Selassie is presiding over the secret negotiations. Informants said the delegates would discuss the opening of a relief corridor to ship food and medicine to starving civilian war victims in Biafran-occupied areas.

"The Nigerian chief negotiator, Anthony Enahoro, returned from the Ethiopian capital Tuesday, saying the Biafran position is not justly optimistic."

Enahoro said the Biafran had been offered openings to give up secession peacefully and to discuss amnesty for anyone, including the rebel leader Lt. Col. Oghuenigbo.

But he added: "I am afraid if the rebels do not utilize the openings we have created, even the emperor's efforts may be to no avail." He referred to coalition efforts by Emperor Haile Selassie of Ethiopia.

Tuesday's session of the Addis Ababa talks was postponed after Enahoro left, and the Biafrans reportedly want to wait for his return. Enahoro said he had no plans to rush back. Femi Oluwole, 40, the youngest of Nigeria's civilian commissioners, was placed in charge of the Lagos delegation.

The Biafran have insisted they never will reunite with Nigeria. They have been driven to this position by the U.S. Department of Transportation Tuesday to investigate the railroad's operation.

NEW YORK (AP) — Today was another day of woes for the Long Island Rail Road's 90,000 daily commuters.

The nation's busiest commuter line canceled 28 morning rush hour trains. The cancellations, which started at 9 a.m., were the result of a slowdown in inspection and repair men in the dispute over the planned discharge of 18 men. The men's union, Lodge 895 of the Brotherhood of Railway Carmen, denies a slowdown and says aging equipment and undermanning of repair facilities are to blame.

As the railroad canceled 28 morning and evening rush hour trains Tuesday, Nassau County Executive Eugene H. Nickerson said the cancellations were necessary to achieve a 10% increase in fare.

Space Leaders Meet in Vienna

VIENNA (AP) — Space leaders and scientists from 67 nations convened today to begin two weeks of talks Tuesday aimed at applying the practical benefits of space technology to the social and economic needs of the world.

The two major space powers, the United States and the Soviet Union, will dominate the meeting, but scientists from 65 other countries will also be present. U.S. representatives include U.S. Secretary General U. Thant, who is expected to address the meeting. He will also describe the effort in a statement as a major step in bridging the gap between space powers and other nations.

He expressed hope that the meeting would not only explain the practical benefits of space technology, but also would result in joint ventures that would bring these benefits to all nations. He also said he would help to alleviate some of mankind's most pressing economic and social problems. Austrian Foreign Minister Kurt Waldheim, president of the conference, said the meeting "will relate to the use of common resources and to the common good of all nations."

Big Arms Cache Found By Allies Near Saigon

SAIGON (AP) — American and South Vietnamese forces reported finding large new enemy caches Wednesday in a tunnel complex beneath the area of village, 25 miles north of Saigon.

The allied sweep began Tuesday and has uncovered 300 rounds of rockets and countless rifle ammunition and 75,000 rounds of automatic weapons. The search operation is designed to wipe out any enemy plans for a new attack on Saigon.

Ten Viet Cong who attempted to flee were killed in a 15-minute clash Tuesday and 10 were named "tunnel rats" captured another 10 prisoners in the underground labyrinth around Cu Dat, officials said.

Military officials believe 250 civilians living in the area are sympathetic to the Viet Cong. It is on a prime infiltration route and less than 10 miles north of a big U.S. Army helicopter base and the headquarters of the South Vietnamese 5th Infantry Division.

Using "neal and search" tactics, U.S. forces have been conducting a search of the area since the start of the war. The search has uncovered a number of caches of arms and ammunition. The caches are believed to be used by the Viet Cong to launch attacks on Saigon.
