Ground Speed Record Beaten By Air Colonel

Alamogordo, N. M., June 9.—A 43-year-old Air Force colonel reached a speed of 423 miles an hour on the ground—a record for a human—during the flight of the Holloman Air Force Base here.

Colonel John P. Stapp, a veteran of aviation medical research, became the second human to go faster than 400 m.p.h. on the ground while sitting in a rocket-propelled sled during tests to determine the effect upon pilots of flying out at very high altitudes and supersonic speeds.

"Things happen too fast to think about them at the time," Col. Stapp said after the run. And he wasn't kidding.

From the starting start to the sudden stop, the run over a 3,000-foot track takes just seven seconds.

The critical factor in the test is the effect of the wind tunnel on the passenger. Officials estimate that on the record run, Col. Stapp's body underwent a pressure of 22 times the force of gravity and his high speed record of 423 m.p.h. was a fine feat of achievement.

Completing this run got a load off his chest.

The only other human to top 400 m.p.h. was Capt. Harold G. G. Cobb, who drove a racer car at 403.135 m.p.h. at Bonneville Salt Flats, Utah, Sept. 16, 1947.

Stapp, chief of the Aero Medical Laboratory at Holloman Air Development Center, made the record on March 19 on the 27th and 28th of his previous fastest time had been 180 m.p.h. at Edwards Air Force Base in California.

The test, designed by Northrop Aircraft, Inc., and conducted in California, consists of two vehicles—the propulsion sled and the test vehicle. The propulsion sled carries 12 rockets, each with a thrust of 1,500 pounds, six of which were used in the March test.

The two vehicles are mounted on special railroad tracks between which a water trough flows. Braking is achieved by controllable metal scoops under each vehicle which scoop up water from the trough.

In future tests, it is hoped to carry volunteers at speeds up to 600 m.p.h. at this altitude and test them to variations in air density at different altitudes. This is the equivalent of 1,800 m.p.h. at 40,000 feet.

The future tests will investigate the effects of tumbling, in addition to those of speed, and the deceleration, on the human body. A special chair on the sled permits the passenger to be rotated backward heels 180 times a minute.

Plan New Office For Power Firm

A new general office building for the Connecticut Power Co. in Waterford was projected today. Plans were requested from a number of construction contractors for a three-story office building on a site on the west side of Hill Road, at the corner of Chamberlain Road. The project covers about fourteen acres.

The company headquarters, which was formerly in New London, has recently been temporarily located in the Hartford Electric Light Co. building on Pearl Street, Hartford. The Waterford site was acquired three years ago and it had been zoned for business use.

The Connecticut Power Co. has long sought a central headquarters location and Waterford seemed logical geographically. The company serves through inter-connections with the Hartford Electric Light Co., electric power requirements in the Middletown, Farmington, Manchester, Thomaston, and Canaan areas. It also provides electricity and gas to the New London, Stamford, and Torrington areas.

The proposed office building will be a three-story and basement structure with entrance on Waterford Hill Road and Chamberlain Road. It will be of steel frame with brick and insulated panel exterior. The main building will be approximately 75 feet by 225 feet, with an attached one-story garage 67 feet by 150 feet in length.

The property will be landscaped in keeping with the company's wish to be a "good neighbor." There will be a cafeteria for the more than 150 employees on duty.

The company has plans for air conditioning the entire building through a system of wells, air conditioning, which will re-use constantly the well water with minimum waste.

Architects for the project are Westcott and Mapp, Inc. If contractors' bids are satisfactory, it is expected that construction will get under way in August, and that the building will be ready for occupancy by January, 1956.

Under present plans, the land and building will be owned by the Connecticut General Life Insurance Co. and leased for a long term to the Connecticut Power Co.

The Doctor Says

Symptoms Appear Four Days to Two Weeks After the Polio Virus Enters the System
By EDWIN P. JORDAN, M. D.

All of today's common childhood questions commonly asked by parents:

Q — What is the incubation period of polio?
A — There are reasons for believing that the time between the time the virus enters the system and the appearance of the first symptoms varies between four days and two weeks.

Q — Are older people immune against polio?
A — Polio is not as common in older people as it is in those under 20, but they do catch it sometimes.

Q — How do you feel about children going swimming during the polio season?
A — There is no real polio "season." In an ordinary year it does not seem necessary to keep the youngsters out of the water just on account of this vague fear. If a community has a lot of cases of polio the problem is somewhat different. Even though the evidence of spread of polio from swimming is conflicting, I would keep my own children out of a pool if there were a good deal of polio around.

Q — If children exercise strenuously, are they more likely to get polio?
A — The latest study on this question that I have seen indicated that exercises taken before the definite symptoms of polio have developed does not increase the severity of paralysis. However, if a youngster is allowed to engage in particularly active sports, and if symptoms have appeared, then the later paralysis is apparently worsened. This probably means that youngsters can be allowed normal exercise even in a polio epidemic in the community, but at the first sign of a sniffle, an upset stomach, or any other illness, they should be put to bed and kept there until a diagnosis has been made or all of the symptoms have disappeared.

Q — My little boy's tonsils should come out. Is there any danger from polio if they are removed in the summer?
A — Summer is usually a pretty good time to remove the tonsils if that is necessary. If there is an unusual amount of polio in your particular community the weight of medical opinion is that operations of this nature are undesirable until the disease has disappeared.

Q — If my child should get polio, what is likely to happen?
A — Recovery in 97 out of 100 cases; no after effects (made out of 100, slight after-effects in 30 out of 100, and severe after-effects in 18 out of 100. These are chances; what happens to the individual child cannot be predicted.

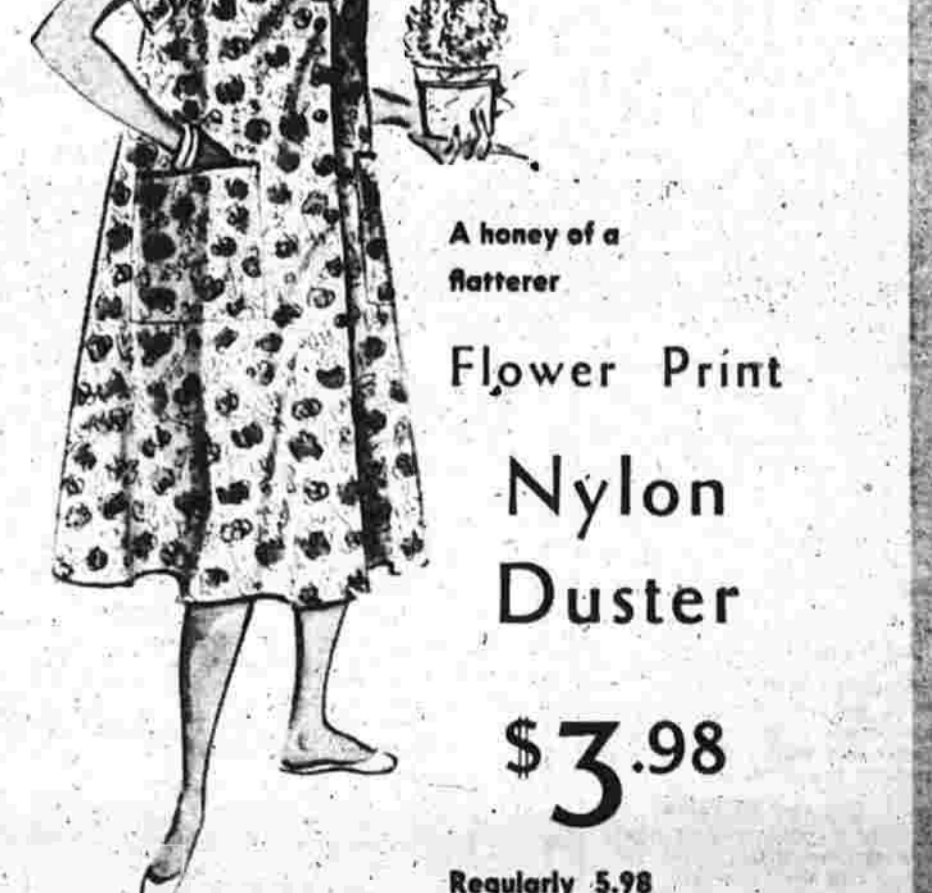

Jobless Claims Decline Here

Jobless claims in the Manchester area were down to 563 from 612 two weeks ago, the state Labor Dept. reported today.

The report also showed that the number of jobless persons on the rolls of unemployment, were also down to 12,617 from 13,000 two weeks ago, as compared with the 13,500 reported for the week ending May 22.

Women continued to constitute the bulk of the claimants for unemployment aid. There were 339 of them drawing compensation during the week ending Saturday, while two weeks ago there were 379.

Throughout the state, meanwhile, claims were continuing to decline for the fourth week. The report listed 35,385 claimants in Connecticut, compared to the 36,412 last week.

The Labor Dept. in its report said that the part of the drop may have been due to the holiday-shortened week.

Urbana, Ill. (AP)—The house fly is getting harder to kill because of its increasing tolerance to spray insecticides, but he dies after eating a new poison devised by William Bruce, associate entomologist of the University of Illinois.

The scientist reports his synthesized compound of arginine phosphate has proved extremely deadly to flies during a year of tests. The new technique in control of the house fly is reported in the *Journal of Economic Entomology*.

The manufacturer of the compound is called Bayer 113-58. A bit of it mixed with water and syrup was painted on partitions, door edges and posts of a calf barn.

After locating the bait, flies fed hungrily. They showed distress symptoms in one to three minutes. Bruce said the flies were unable to move at all in five to fifteen minutes. Flies that had fed sufficiently on the bait and showed distress symptoms never recovered.

The special compound, not yet available to the public, was used in tests because a single application continued to attract flies and kill them throughout the summer. Chlorophosphate or toxicants probably could not be used, he said.

The product has not been passed upon by the United States Food

Those released under bond, told reporters the attack on Zimmerman's home came after he had "imposed a curfew on the school. Lewis are cowboy-type blue jeans."

The blasts had been set off later at the home of Miss Ann Fullerton, biology teacher at the Bethesda-Chevy Chase School, a restaurant in Silver Spring, Md., and a private residence for whose selection police were unable to account, and the Bethesda Public Library. The library blast came Saturday night.

Capt. G. W. Linticum, Montgomery County chief of detectives, and Det. Lt. John T. Leahy agreed they had been unable to establish any motive for the outbreaks except that the boys "were seeking a thrill." They said there was no actually organized gang.

The names of the juveniles under arrest are not customarily released here, but the county court voted an exception for the bombing outbreak.

They said they had worked a plan to break into a hardware store to obtain ammonium nitrate for more explosive."

Donnelly, who had handled legal and financial matters for all three, was released on bond last yesterday.

Dundon, still in custody, was questioned for more than two hours last night by Sheriff Christ and County Solicitor Christ M. Kelly. The officials said no comment on this action, but it was after the fact that he expected more developments.

Donnelly took his life at his own apartment in a frame home on Crooked Lake about five miles from here.

assured of election. And he is the only Democrat holding a statewide job. He defeated former Republican Atty. Gen. Fred N. Howe of Los Angeles on the GOP ticket by a landslide vote.

Graves, for 20 years executive director of the League of California Cities and once Warren's Civil Defense chief, claimed victory on the Democratic ticket in a statement declaring "Knight has shot his bolt."

Shortly before the campaign started Roosevelt's estranged wife, Romelle, 38, charged him in a separate maintenance suit with adultery, naming three correspondents, and filed a letter dated in which he admitted infidelities with nine other women.

Roosevelt, 45, has denied any misconduct. He said he signed the letter to save his wife and their three children \$1,625 monthly temporary support, spent little money on the campaign compared with his unsuccessful race for governor against Earl Warren in 1950. He conducted city question and answer sessions in 225 homes, and appeared at a few public meetings.

Anjin, a Rongelap leader, described the March 1 explosion: "First saw light, then smoke. Smoke went up, up, and right through the clouds. Later heard and felt blast. Wind as strong some people fell down. It banged doors."

Of the 82 Rongelaps, about 45 suffered radiation burns. Many of these were slight. One man, 20-year-old Tom Nari, still has a bad burn on the back of the right ear. Three months after the explosion, he was in a hospital when the ash began falling.

"Some were frightened," said a Rongelap medical aide. "By night the residents were crying. Many adults were sick."

A few days after leaving, some of the residents began losing their hair. Three days after the blast, a destroyer arrived to evacuate the residents. All started taking showers.

The evacuation from Rongelap and Ulrik was completed in two days. The affected people received medical assistance here on the Kwajalein atoll. A top medical team was flown from the Ulrik to the atoll, arriving March 30.

In April a survey party visited the two affected atolls. This consisted of representatives of Joint Task Force 7; the Army, Navy, Chief, Pacific Fleet; High Commissioner, Trust Territory of the Islands; the Atomic Energy Commission's engineer contractors Holmes and Narver; and the native magistrates of Rongelap and Ulrik.

It was decided that Ulrik people could return home, with adequate water and food supplies to be furnished them. It was determined the Rongelap people would have to stay off their atoll for a year. They will live meantime on Ulrik. The atoll in the Marshes atoll. There the AEC contractors have built an entirely new village of 27 buildings.

Anger Among People "There is anger among some people," Anjin said. "I think it will disappear if we get back home. They trust the American people."

Anjin said that the Rongelaps have been well taken care of since their arrival on Kwajalein with all the food, clothing, medical care and entertainment they need. The Marshallese people are not angry. They like happily and Hawaiian Americans in the area "felt a personal responsibility for the native people."

Scientists Protest Oppenheimer Ban
Los Alamos, N. M., June 9.—A petition from more than 250 Los Alamos atomic scientists strongly criticizes government handling of the case of Dr. J. Robert Oppenheimer.
And the scientists want the action taken against Oppenheimer may make it possible to re-examine the full government laboratories with trained workers.
The petition, sent in the form of a telegram to the President, the Atomic Energy Commission, and the Energy Committee, said:
"We agree that it is a prerogative of government to choose its own advisors.
"But it is inexcusable to employ the personnel selection system as a means of dispensing with the services of a loyal but unwanted consultant."
Dr. Fred L. Rice, who sent the telegram and helped collect the names, said it bore some 252 signatures from 154 Los Alamos scientists, one day and representing 80 per cent of the scientists here.
Oppenheimer headed the Los Alamos Scientific Laboratory when it developed the atomic bomb during World War II. He recently was barred as a security risk from further classified information and a three-man board, although holding Oppenheimer loyal, refused to reinstate him.
